I. PROJECT BACKGROUND AND SCOPE OF WORK

1. ABOUT GAIN AND HARVESTPLUS

The Global Alliance for Improved Nutrition (GAIN) is a Swiss-based foundation launched at the UN in 2002 to tackle the human suffering caused by malnutrition. Working with both governments and businesses, we aim to transform food systems so that they deliver more nutritious food for all people. At GAIN, we believe that everyone in the world should have access to nutritious and safe food. We work to understand and deliver specific solutions to the daily challenge of food insecurity faced by poor people. By understanding that there is no "one-size-fits-all" model, we develop alliances and build tailored programmes, using a variety of flexible models and approaches. We build alliances between governments, local and global businesses, and civil society to deliver sustainable improvements at scale. We are part of a global network of partners working together to create sustainable solutions to malnutrition. Through alliances, we provide technical, financial and policy support to key participants in the food system. We use specific learning, evidence of impact, and results of projects and programmes to shape and influence the actions of others.

At HarvestPlus, we believe that hidden hunger should not be inevitable for the people most at risk. We break down silos between agriculture and nutrition to develop creative solutions to hidden hunger. Our food-based approach targets some of the most vulnerable populations around the world. We use a process called biofortification, which adopts conventional breeding to improve crops. This approach complements other nutrition interventions, and is evidence-based, cost-effective, and sustainable. We work across the entire value chain to develop and deliver nutrient enriched seeds, grains and foods to the people who need it the most via a large collection of innovative and traditional supply chain activities. HarvestPlus is part of the CGIAR Research Program on Agriculture for Nutrition and Health (A4NH). CGIAR is a global agriculture research partnership for a food secure future. Its science is carried out by its 15 research centres in collaboration with hundreds of partner organizations.

GAIN and HarvestPlus share an ambition to expand coverage of biofortified nutrient dense foods to at least 190 million consumers by 2022, realizing a higher reach of up to three times this (600 million) from the initial investment by 2028. The current focus will be on biofortified varieties of six highly promising crops, developed by HarvestPlus and its partners. These crops form the frontline cluster of sentinel nutritious staple crops to be considered for commercialisation at scale by the partnership. We define commercialisation – the priority delivery approach – as the process of introducing a product into commerce or making it available in the market, rather than producing solely for family consumption.

In May 2018, HarvestPlus and GAIN launched a landmark partnership to accelerate progress in improving access to biofortified seeds, grains and foods via commercial channels with the Commercialisation of Biofortified Crops (CBC) programme. The CBC programme works with national partners to catalyse commercial markets for biofortified crops and foods in six countries with pervasive levels of malnutrition: Bangladesh, India, Kenya, Nigeria, Pakistan, and Tanzania. Initial funding for the program is from Germany's Federal Ministry of Economic Cooperation and Development (BMZ) and the Dutch Ministry of Foreign Affairs.

The partnership brings together two leading actors in the global nutrition space. It combines the deep expertise of HarvestPlus in all aspects of biofortification with GAIN's proven track record of working with fortification and food companies to create sustainable market models for nutritious food systems.

The Commercialization of Biofortified Crops (CBC) programme is designed to scale up the commercialization of biofortified foods. The activities of the programme aim to achieve the following three goals with a sound evidence-based footing:

1. Improve access to inputs and markets for biofortified seeds and food products by: identifying and overcoming barriers to access and acquisition of biofortified seeds, accelerating business



- development along the supply chains, and ensuring iterative research and development services are opened to link consumer and processor needs to continued crop and product modification.
- 2. Generate demand for these nutrient-rich staple crops using a demand creation approach that taps into the rational and emotional drivers of consumer choices for nutrient rich staples.
- 3. Improve the enabling environment for biofortified seeds and food products through advocacy, catalytic financing, and technology licensing services.

2. BACKGROUND

As part of this work, GAIN and HarvestPlus are jointly issuing this Request for Proposals (RFP). GAIN will be the administrative lead organisation for this RFP.

The purpose of this RFP is to engage services of a Service Provider to develop and implement a comprehensive strategy targeted at micro-, small- and medium-scale enterprises (MSMEs) across the value chain for biofortified cassava and maize to build capacities on efficient business management practices to make businesses bankable and investment ready, and improve access to funding in selected states in Nigeria.

2.1. FINANCING OF SMALL AND MEDIUM SCALE ENTERPRISES IN NIGERIA

Nigeria is one of the largest economies in Africa, and home to different businesses, ranging from micro, small, medium, and large enterprises. These enterprises play a vital role in the growth and development of the Nigerian economy. Food enterprises in Nigeria are dominated by small and medium scale businesses, with specialization in production and processing of food commodities consumed across homes in Nigeria.

According to the Central Bank of Nigeria, SMEs are broadly defined as businesses with turnover of less than N100 million per annum and/ or less than 300 employees. The Bank of Industry (BOI) further classified SMEs based on the number of staff, assets, and annual turnover. According to BOI, microenterprises have less than 10 employees, an asset of less than 5 million Naira and an annual turnover of less than 20 million Naira; small scale enterprises have 11 to 50 employees, an asset of less than 100 million Naira but greater than 5 million Naira and an annual turnover of not more than 100 million Naira. On the other hand, medium enterprises have a staff strength of more than 51 but less than 200 people, a total asset of more than 100 million Naira but less than 500 million Naira and an annual turnover of not more than 500 million Naira; while large-scale enterprises have values higher than these.

According to NDHS 2018, approximately 66% of Nigerian children are at risk of vitamin A deficiency due to a lack of diversity in their diets as a consequence of poverty. Ensuring food and nutrition security is one of the most pressing challenges for sustainable social and economic development in Nigeria. Meeting this need presents an important opportunity for tackling malnutrition. Diets of rural Nigerians are particularly poor, and many Nigerians currently experience vitamin and mineral deficiencies leading to severe health outcomes including premature and preventable death especially in under 5-year-olds.

GAIN and HarvestPlus understand that micro to large scale enterprises are key to national growth and development and will collaborate to support the commercialisation of biofortified cassava and maize in Kaduna, Niger, Nasarawa, Oyo, Osun, Anambra, Cross River and Imo states. Specifically, they will work with key businesses along the cassava and maize value chains to build their capacities and scale up production and utilization of these crops.



To date, GAIN, HarvestPlus have developed implementation plans for both biofortified crops and we commissioned an assessment to understand the gaps that impact businesses from accessing funds in Nigeria. We found that the key issues affecting the SMEs in the country, can be grouped into four categories namely:

- Unfriendly business environment,
- Poor funding,
- · Low managerial skills, and
- Lack of access to modern technology.

Additionally, SMEs are more likely to face funding gaps because they are small and do not have adequate financial structures in place. In addition to this, most MSMEs have poor management structures and exhibit key main risks which makes financial institutions reluctant to lend to them. As a recommendation for businesses, the need to form participant/borrower's groups improves chances of accessing funds in addition to capacity support on best practices.

3. OBJECTIVES

The main objective is to develop and implement a strategy targeted at micro-, small- and medium-scale enterprises (MSMEs) across the value chain for biofortified cassava and maize to build capacities on efficient business management practices to make businesses bankable and investment ready, and improve access to funding.

The scope of this work will focus on Osun, Anambra, Cross River and Nasarawa States for vitamin A cassava (VAC), and Imo, Kaduna, Niger, Oyo for Vitamin A Maize (VAM) while utilizing findings from our previous research work.

The specific objectives are to:

- Develop and implement a strategy that will build capacities of MSMEs across the value chain for biofortified cassava and maize in selected states and facilitate making these businesses investment ready.
- 2. Support selected businesses, to improve efficiency in business management practices and growth to achieve commercialization of their biofortified food products.
- 3. Facilitate linkages between MSMEs across VAM and VAC value chains with institutions that provide financial and or agro-credit facilities to improve access to funding for businesses.

The Service Provider should propose how the above-mentioned objectives would be met based on their expertise and team structures.

4. SCOPE OF WORK AND DELIVERABLES

4.1. SCOPE OF WORK

The successful applicant shall provide the following services:

- Develop a detailed strategy for review and approval by GAIN and HarvestPlus.
- Carry out all aspects of the strategy, including capacity development support across the eight states, including production of training materials and other activities as detailed in the strategy.
- Draft monthly progress reports on all activities.
- Draft a final report, including overview of the strategy, activities, results, and future recommendations.

II. INSTRUCTIONS FOR RESPONDING

This section addresses the process for responding to this solicitation. Applicants are encouraged to review this prior to completing their responses.

1. CONTACT

Key programme and technical staff from GAIN and HarvestPlus are part of the selection team of the organisation and will review the proposals. They will be available via email to respond to clarifications on this solicitation. Reponses will not be confidential except in cases where proprietary information is involved.

2. BUDGET

Applicants are required to provide GAIN and HarvestPlus with a detailed budget in US Dollars, including fees/travel/accommodation and any other direct costs to be incurred in the delivery of the Scope of Work. Include a brief narrative justification for line items included. The budget must be inclusive of all taxes/VAT and



indirect costs. The final budget amount will have to be approved by GAIN and HarvestPlus prior to starting the project.

3. FORMAT FOR PROPOSAL

The proposal needs to be formatted as two separate documents:

- Technical proposal:
 - i. Description of previous relevant work (maximum 1 page);
 - ii. Composition of team with names and brief biographies of all key staff (maximum 3 pages);
 - iii. Detailed proposal explaining how the areas of work mentioned in Scope of Work will be addressed, including risk and mitigation strategy and timeline (maximum 10 pages);
 - a. An outline of the proposed strategy and implementation plans to make businesses investment ready strengthen in the eight states, including supporting rational illustrated with relevant Initial thoughts.
 - b. Details on how the agency intends to build the capacities of selected businesses to make them improve business efficiency and operations.
 - c. A plan on how agency will support businesses with linkages to credit/financial institutions.
 - iv. References.
- Financial proposal:
 - i. Budget;
 - ii. Detailed budget justification;
 - iii. Offer of services.

4. SUBMISSION

5. DEADLINE

Completed proposals should be submitted to rfp@gainhealth.org by 12:00 pm WAT on 2 July 2021.

6. UNACCEPTABLE

The following proposals will automatically not be considered or accepted:

- Proposals that are received after the RFP deadline.
- Proposals received by fax or post.
- Incomplete proposals.
- Proposals that are not signed.

7. REVISIONS

Proposals may be revised by electronic mail and confirmed by hard copy provided such revision(s) are received before the deadline.



8. ACCEPTANCE

GAIN and HarvestPlus will not necessarily accept the lowest cost or any of the proposals submitted. Accordingly, eligibility requirements, evaluation criteria and mandatory requirements shall govern.

9. COMPLETION

- Proposals must be submitted on official letterhead of the lead organisation or firm and must be signed by a principal or authorising signatory of the lead firm or organisation.
- In case of errors in calculating overall costs, the unit costs will govern.
- It is the applicant's responsibility to understand the requirements and instructions specified by GAIN. In the event that clarification is necessary, applicants are advised to contact GAIN at rfp@gainhealth.org prior to making their submission before the deadline specified in the timeline above.

GAIN and HarvestPlus reserve the right to reject any or all submissions or to cancel or withdraw this RFP for any reason and at its sole discretion without incurring any cost or liability for costs or damages incurred by any applicant, including, without limitation, any expenses incurred in the preparation of the submission. The applicant acknowledges and agrees that GAIN and HarvestPlus will not indemnify the applicant for any costs, expenses, payments or damages directly or indirectly linked to the preparation of the submission.

11. REFERENCES

GAIN and HarvestPlus reserve the right, before awarding the proposal, to require the applicant to submit such evidence of qualifications as it may deem necessary, and will consider evidence concerning the financial, technical and other qualifications and abilities of the applicant.

12. RELEASE OF INFORMATION

After awarding the proposal and upon written request to GAIN, only the following information will be released:

- Name of the successful applicant.
- The applicant's own individual ranking.



III. TERMS AND CONDITIONS OF THIS SOLICITATION

1. NOTICE OF NON-BINDING SOLICITATION

GAIN reserves the right to reject any and all bids received in response to this solicitation and is in no way bound to accept any proposal. GAIN additionally reserves the right to negotiate the substance of the successful applicants' proposals, as well as the option of accepting partial components of a proposal if deemed appropriate.

2. CONFIDENTIALITY

All information provided as part of this solicitation is considered confidential. In the event that any information is inappropriately released, GAIN will seek appropriate remedies as allowed. Proposals, discussions, and all information received in response to this solicitation will be held as strictly confidential.

3. RIGHT TO FINAL NEGOTIATIONS ON THE PROPOSAL

GAIN reserves the right to negotiate on the final costs, and the final scope of work of the proposal. GAIN reserve the right to limit or include third parties at GAIN's sole and full discretion in such negotiations.

4. EVALUATION CRITERIA

Proposals will be reviewed by the Selection Team. The following indicate a list of the significant criteria against which proposals will be assessed. This list is not exhaustive or 100% inclusive and is provided to enhance the applicants' ability to respond with substance.

Applicants are required to submit the following information, conforming to the guidelines given in this section:

- Understanding of the scope of work:
 - Proposal shall demonstrate a clear understanding of the project objective and deliverables as outlined in Section I.
- Demonstrate a clear understanding of the technical requirements of this RFP:
 - o Providing detailed technical documentation of the proposed strategy.
 - o Evidence of experience delivering solutions using the proposed information technology platform.
- The creative and methodological approaches required to implement each of the parts of the scope of work.
- Comprehensiveness of work plan and reasonableness of proposed time frame:
 - o Proposal shall include a feasible work plan to ensure successful completion of deliverables.
 - The work plan details how activities will be coordinated.
- Detailed budget and cost-effectiveness of proposed approach:
 - Evidence of cost-effective approaches to undertaking the scope of work within the proposed budget.
 - > Proposal shall identify possible challenges and include creative approaches to addressing them.
- Management and personnel plan:
 - The team members working on this project shall have the relevant qualifications and overall experience required to successfully implement the project.



- Roles and responsibilities of each team member shall be clearly defined. GAIN and HarvestPlus shall each have one main contact person clearly identified in the proposal.
- A duly completed offer of services.

GAIN reserves the right to contact the individuals and contractor(s) in order to verify the information provided as part of the Proposal.

5. REVIEW PROCESS

The review process will involve a Review Panel with participants selected by GAIN and HarvestPlus.

6. LIMITATIONS WITH REGARD TO THIRD PARTIES

GAIN does not represent, warrant, or act as agent for any third party as a result of this solicitation. This solicitation does not authorise any third party to bind or commit GAIN in any way without GAIN's express written consent.

7. COMMUNICATION

All communication regarding this solicitation shall be directed to appropriate parties at GAIN. Contacting third parties involved in the RFP, the review panel, or any other party may be considered a conflict of interest and could result in disqualification of the proposal.

8. FINAL ACCEPTANCE

Award of a Proposal does not imply acceptance of its terms and conditions. GAIN reserves the right to negotiate on the final terms and conditions including the costs and the scope of work when negotiating the final contract to be agreed between GAIN and the applicant.

9. VALIDITY PERIOD

The offer of services will remain valid for a period of 60 days after the Proposal closing date. In the event of award, the successful applicant will be expected to enter into a contract subject to GAIN's terms and conditions.

10. INTELLECTUAL PROPERTY

Subject to the terms of the contract to be concluded between GAIN and the applicant, the ownership of the intellectual property related to the scope of work of the contract, including technical information, know-how, processes, copyrights, models, drawings, source code and specifications developed by the applicant in performance of the contract shall vest entirely with GAIN.

11. SCOPE OF CHANGE

Once the contract is signed, no increase in the liability of GAIN or in the fees to be paid by GAIN for the services resulting from any change, modification or interpretation of the documents will be authorised or paid to the applicant unless such change, modification or interpretation has received the express prior written approval of GAIN.
